Model W 220 and W 215

Dear All,

It has been observed that under extreme ambient conditions, e.g. vehicle's engine at idle speed, high outside temperatures and blower at maximum setting, the temperature at the fuse for the blower regulator could increase in isolated cases. Hence please install a wiring harness with a fuse holder (Part No. A 220 540 95 07 05) in to these vehicles **during next workshop visit**.

The details of the vehicles in your responsibility is attached herewith. The vehicles where the concerned dealer could not be identified are also included in the list. If such a vehicle reports to your dealership, then please carryout this action otherwise provide us a written confirmation that the vehicle does not report to your workshop.

Please refer WIS document no. AN83.10-P0001M for work instructions. Please note that the procedure in AN83.10-P-0001-01MN must be changed as of step 5:

Step 5: Unpin the red/yellow wire from the brown fuse carrier and cut off wire lug.

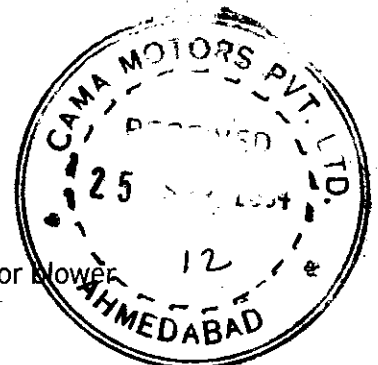
Step 6: Omitted

Step 7: Cut off plug from wiring harness A 220 540 95 07 05 and solder to unpinned red/yellow wire from step 5. Afterwards, insulate wire with heat-shrink wrapping.

Perform the rest of the tests.
