- 1. Ensure a voltage supply of more than 12.5V by hooking up a charger to the battery. Do not connect the charger's ground cable to the battery's ground terminal, but rather to one of the vehicle's ground points, e.g. underneath the battery control unit.
- 2. Using the following list, determine which hydraulic unit must be used:

Hydraulic units ordered from the replacement parts department are so-called "wet hydraulic units". They are already filled with brake fluid. However, the part number found on SBC hydraulic units is a part number for a so-called "dry hydraulic unit" installed at the factory. For this reason the part number on the packages of the replacement hydraulic units is different from the part number on the originally installed hydraulic units. Replacement SBC hydraulic units delivered from the replacement parts department are always the most up-to-date versions. This is why the part number on delivered hydraulic units may not be the same as the part number used to order them. In this case the SBC hydraulic units have been automatically updated to the most recent versions.

- 4. The new hydraulic units are to be marked with a green dot on the SBC hydraulic unit's pump motor.
- 5. If the STAR Diagnosis test for air in the system was not passed or was interrupted, this test must be repeated. If necessary, bleed the SBC system a second time.
- 6. Close up all of the hydraulic connections on old SBC hydraulic units with the replacement part stop plugs from the new hydraulic units so as to avoid brake fluid from spilling out during transport.
- 7. Carefully pack old SBC hydraulic units to avoid any damage to intake connection fittings during transport.
- 8. Send back old hydraulic units together with the quick test reports through the usual warranty channels.

With reference to the subject matter, as confirmed during telecon, you have already received the related mails sent earlier to you. In this connection, please note that till the final release of the Campaign by DCAG, the letter to be sent to Customers will not be available with us. Therefore, with a view to ensure that each concerned staff member in your workshop is fully sensitised about the critically, urgency & importnace of this matter, please note & comply with the following:

We are arranging for the visits of the Service Representatives to each Dealership so that the work process is very clearly demonstrated and explained to your Team members. In view of the same, please go in contact with the Service Representative (responsible for your workshop), as soon as you have a W211 or R230 in your workshop (either from a Customer or from your Retail stock).

Ensure that the cars in your Retail stock are recoded on priority and Completed at the earliest.

Please ENSURE that for each vehicle after the recoding process, take a STAR-Print out as a proof of no-defect in the vehicle.

As the contents of the Letter to be sent to the Customers for this recall action are still awaited, to ensure that the activity of this campaign goes fast, please use following means to get the affected cars to your workshops at the earliest:

Please send a normal Service Reminder to the Customer, if the car has not visited the workshop for more than a year OR where, based on the history the vehicle is expected to have covered the required mileage for the next Service. Thus when the car visits for the service, please carry out the recall action and ensure that it is properly recorded in the job card. Additionally, for cars in the valid range of the Free Inspection period i.e. 3000-6000 kms mileage, please send a reminder to

During such visit ensure that the Recall action is completed as a first priority.
