#### Dear Shri Cama,

This is with reference to your letter dated 10<sup>th</sup> March 2011, repeatedly requesting us to take up investigation of certain faults in Mercedes Benz vehicles as reported by you.

As already clarified in our previous letter, ARAI is not in a position to take up the investigation studies. We neither have specific technical expertise nor software tools to debug ECUs or special control systems deployed on the said vehicle model. It is further clarified that the matter is outside the purview of mandatory requirements under the Central Motor Vehicles Rules (CMVR). Hence we are not in a position to advise you regarding any specific action in this matter.

It is further noted that the envelope, which was marked to us, also contained original letters addressed to Mr. Salvi, Mercedes Benz India Pvt. Ltd. and Mr. Amit Patel, Sintex Industries Ltd.
