We wish to once again bring to your kind attention the major issue pertaining to faulty and highly dangerous vehicles manufactured by Mercedes Benz India Private Ltd..., Daimler AG.

By the earlier correspondences vide several letters addressed to Mr. S.R. Marathe (Director), ARAI we had placed the matter but no further response has been received by us. Even from Mercedes Benz India Private Ltd... we have received no technical clarification or suitable reply for over two years and therefore we approached the Ambassador for Germany in India vide several letters to which also we have received no reply. Before this date we failed to receive a reply from the German Trade Commissioner also.
